Seller's Guarantee:

The Seller guarantees this puppy/dog to be of sound health and temperament at the time of sale. A puppy well check will be performed by the seller's veterinarian and at that time your puppy will receive its first set of vaccinations. In addition, a health record of all shots and worming will be provided by the Seller.

The breeder guarantees that the puppy will be free from active hip dysplasia, defined as radiographic results determined to be severe by the Orthopedic Foundation of America. Should severe be diagnosed by a certified orthopedic veterinarian during the puppy's first two years of life, the buyer will notify the seller of the condition within 7 days. The buyer will, upon request, provide the breeder with all relevant x-rays and/or reports for examination by the breeder's certified orthopedic veterinarian of choice. If confirmed by breeder's veterinarian; we will replace the dog (due to crippling dysplasia) as soon as possible with a replacement of equal value to the dog at the time of original purchase. Should the Buyer prefer to retain the said dog, the Buyer thereby forfeits any replacement, unless other arrangements are mutually agreed

upon. This guarantee is null and void if Penn-Hip procedure has been used at any time during life of the dog.

The Buyer understands that the GSD breed may have other health concerns not covered in this Warranty. Conditions described as "Genetic Predispositions" are not passed from parents to offspring but are common throughout the entire breed.

The Breeder **does not** Guarantee against any non-genetic condition, disease or injury that is caused by: inappropriate diet, excessive exercise, injury (deliberate or accidental), abuse, untimely or inappropriate veterinary care. The breeder cannot guarantee the ultimate size, weight, or suitability for specialized activities such as, but not limited to, **breeding**, therapy/ service, agility, showing, protection, tracking, etc.

The puppy is eligible for registration with the American Kennel Club as a purebred German Shepherd or Pink Papers from the German SV.

This Guarantee applies to the original purchase ONLY and is not transferable.

Buyer's Responsibility:

The buyer agrees to obtain a health exam from a veterinarian of the buyer's choice at their own expense within 3 (three) days of pick-up/delivery of pup.

If at any time the Buyer can no longer retain possession of this dog, the Seller is to be notified and given first option of resuming full ownership of dog. The dog will be returned with all AKC papers and medical records .

Registration papers will either be given with the puppy or transferred to the Buyer immediately upon receipt from the AKC. The Buyer agrees to register the dog using the kennel name of **vom Sudwesten**.

Up until the time of delivery, Breeder assumes full liability for the dog and its actions. At the time of delivery, Breeder releases all ownership responsibilities to the Buyer.

The entire agreement between the parties is contained herein. In the event of a dispute, Arizona will have jurisdiction over the matter in Maricopa County under the laws of the State of Arizona.

By signing, all parties have read and agreed to this contract in its entirety.
